RESOLUTION ADOPTING A CREDIT CARD POLICY FOR THE VILLAGE OF BARRINGTON HILLS

WHEREAS, the Village of Barrington Hills (the "Village") located in the Counties of Cook, Kane, Lake and McHenry in the State of Illinois, is a home rule municipality; and

WHEREAS, for purposes of certain purchasing for the Village, the Village has previously authorized the use of credit cards assigned to the Village President, the Director of Administration and the Chief of Police and employees these Officers may designated to hold credit cards for purchasing purposes; and

WHEREAS, in consultation with the Village's auditors, it is deemed appropriate and in the best interests of the Village to adopt a Credit Card Use Policy in line with the policies and purposes established for credit card use at this time, as it set forth in the Credit Card Use Policy, attached hereto and made a part hereof by reference as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, located in the Counties of Cook, Kane, Lake and McHenry, Illinois, as follows:

The recitals set forth above are incorporated herein and made a part **SECTION ONE:** hereof.

SECTION TWO: The Credit Card Use Policy attached hereto and made a part hereof by reference as Exhibit A, is hereby adopted as the Village of Barrington Hill's Credit Car Use Policy to be followed by all Officer and employees authorized to use a credit card in the name of the Village of Barrington Hills.

This Resolution shall take effect immediately upon its passage and **SECTION THREE:** approval as provided by law.

VILLAGE OF BARRINGTON HILLS CREDIT CARD USE POLICY

Only authorized Officers and Employees of the Village may use a credit card issued in the name of the Village. Designated Officers are: President, Police Chief, and Director of Administration. Each Officer may designate an employee for purposes of use of a Village credit card.

Any Officer or employee found guilty of illegal or unauthorized use of a Village credit card (intentional or not) may be subject to the penalties allowed by law and/or disciplinary action, up to and including termination.

CARDHOLDER RESPONSIBILITIES

- a. Ensure that the credit card is used in compliance with the Village's Credit Card Use Policy and its Purchasing Policies. For such purposes, all Officers and Employees issued a credit card shall execute the Credit Card Holder Agreement attached hereto as Exhibit 1.
- b. The Officer and/or employee issued the credit card must provide the Village Treasurer a photocopy of the front and back of the credit card, and shall be responsible for the protection and custody of each card issued, and shall immediately notify the Village Treasurer if the card(s) is lost or stolen.
- c. A Village credit card can be used only for the purchase of goods or services for the Village.
- d. Village credit card users should notify vendors or merchants that the credit card transaction is tax exempt from Illinois Sales and Use taxes if the credit card is used for a purchase of goods or services in the State of Illinois.
- e. The credit card shall not be used for cash advances, personal use or any other type of personal purchase.
- f. All purchases made with a Village credit card must be reported with receipts and associated documentation detailing the goods or services purchased, cost, date of the purchase and the official business explanation therefore.
- g. All such documentation set forth in paragraph f. shall be tendered to the Village Treasurer in a timely manner to reconcile against each monthly credit card statement.
- h. Any credit card in the possession of an Officer or employee must be immediately surrendered to the Village Treasurer upon termination of appointment or employment. The Village reserves the right to withhold final payroll checks and payout of accrued leave until any card(s) is surrendered.

INTERNAL CONTROL PROCEDURES

The Director of Administration, assisted by the Village Treasurer, shall be responsible for the issuance and retrieval of assigned Village Credit Cards, and generally for ensuring compliance with this Policy. Such duties shall include, but not be limited to:

- a. Maintaining a record of issuance and retrieval of Village credit cards and overseeing compliance with this Policy.
- b. Accounting and payment of expenses, and ensuring all documentation as required is submitted.
- c. Ensuring accuracy of the statement and that activity and account information is noted on the credit card statement for each line of entry.
- d. Compliance with Illinois law relative to records retention for safekeeping of statements and receipts.

EXHIBIT 1

Village of Barrington Hills Credit Cardholder Agreement

Credit cards issued in the name of the Village of Barrington Hills shall be used only for the official business of the Village of Barrington Hills. Each credit card must be used in accordance with the provisions of the Credit Card Use Policy of the Village of Barrington Hills.

Violations of the Credit Card Use Policy shall result in revocation of use privileges. The Village of Barrington Hills will investigate and commence, in appropriate cases, criminal prosecution against any individual found to have used a Village credit card for improper purposes.

Any Officer or employee found guilty of illegal or unauthorized use of a Village credit card may be subject to penalties provided by law and/or disciplinary action, up to and including termination.
