Dear Board and President McLaughlin,

Please accept this letter as my objection to the provision of bike lanes and/or other accommodations for bike riders in Barrington Hills. The construction of a bike corridor through Barrington Hills or any accommodation to bikers to this area is, in my opinion, a grave disservice to the residents of this community.

My personal experience with bikers in our community has not been pleasant. From the seemingly customary practice of biking groups acquiring most of the roadway without access to pass, to finding bikers' bottles and wrappers in my front lawn, to hearing obscenities when stopped in a car with my children and passed by a group of bikers, I have not been impressed with the lack of respect provided to the residents of Barrington Hills by visiting bikers. While I understand hearsay is less probative than actual testimony (and hopefully our friends have already personally attested to this), but by far the worst encounter with bikers was told to my husband and I by our friends who live on Oak Knoll, who witnessed a biker defecating on the side of their property.

I do not believe that a bike corridor or accommodation in any area of Barrington Hills will redirect biking traffic to that particular access only, but will rather welcome bikers from other communities to our own, creating additional traffic, garbage and disrespect towards the members of our community. As such, I ask that the proposed resolution in opposition to the provision of bike accommodations be adopted by the Board.
