## ORDINANCE AMENDING SECTIONS 5-2-1, 5-3-8, 5-3-9, 5-5-2, 5-5-3, 5-5-6-3 and 5-5-11 OF TITLE 5 OF THE ZONING CODE TO RESOLVE CONFUSING AND/OR CONTRADICTORY LANGUAGE

WHEREAS, the Zoning Board of Appeals ("ZBA") for the Village of Barrington Hills, Illinois (the "Village") held a public hearing on May 13, 2009 to discuss the proposal of the ZBA to amend Sections 5-2-1, 5-3-8, 5-3-9, 5-5-2, 5-5-3, 5-5-6-3 and 5-5-11 of the Village Zoning Ordinance (the "Zoning Code") with respect to "housekeeping" amendments necessary to clean up unnecessary, confusing and/or contradictory language within the Zoning Code; and

WHEREAS, the ZBA finds it to be in the best interest of the Village to amend the Zoning Code regarding. "housekeeping" amendments necessary to clean up unnecessary, confusing and/or contradictory language within the Zoning Code and therefore, pursuant to Section 5-10-6(G) of the Village Code, the ZBA submits to the Village Board of Trustees the following findings and recommendations regarding amending Sections 5-2-1, 5-3-8, 5-3-9, 5-5-2, 5-5-3, 5-5-6-3 and 5-5-11 of the Zoning Code.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington Hills, Cook, Kane, Lake and McHenry Counties, Illinois, as a home rule municipality, the following:

- <u>Section 1</u>. Findings. The Village Board hereby finds that the recitals contained in the preambles to this Ordinance are true and correct and does incorporate them into this Ordinance by this reference.
- <u>Section 2</u>. <u>Recommendation</u>. Title 5 of the Village Code shall be, and the same hereby is, amended to reflect the recommendations of the Zoning Board of Appeals as found in Exhibit A.
- Section 3. Validity. Should any part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of this Ordinance as a whole or any part thereof other than the part declared to be invalid.
- Section 4. Superseder and Effective Date. All resolutions, motions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded; and this Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
