

**RESOLUTION AUTHORIZING ADVOCATE HEALTH CARE NETWORK  
"THE FAMILY FITNESS RUN" RACE  
BY THE VILLAGE OF BARRINGTON HILLS**

**WHEREAS**, in the opinion of the corporate authorities of the Village of Barrington Hills ("Village"), it is for the best interests of the Village to hold the "Family Fitness Run" Race on the route attached hereto as Exhibit "A" ("Marked Route") beginning at 7:15 a.m. on July 4, 2014; and

**WHEREAS**, the "Family Fitness Run", formerly known as Run For The Arts, will require the partial or complete closing of the streets located on the Marked Route; and

**WHEREAS**, pursuant to Section 5/4-408 of the Illinois Highway Code (605 ILCS 5/4-408), the Village is required to assume all responsibility and liability involved in the closing of any portion of a public highway within its jurisdiction.

**NOW, THEREFORE, BE IT RESOLVED**, by the President and Board of Trustees of the Village of Barrington Hills, a home rule municipality located in the Counties of Cook, Kane, Lake, and McHenry in the State of Illinois, the following:

**Section 1. Recitals.** The foregoing recitals are hereby incorporated into this Resolution as findings of the President and Board of Trustees.

**Section 2. Responsibility and Liability.** The President and Board of Trustees agree that the Village will assume, to the extent required pursuant to section 5/4-408 of the Illinois Highway Code, full responsibility for the direction, protection and regulation of traffic during the time the Family Fitness Run is in effect, and all liabilities for damages of any kind occasioned by the closing of said Route for the Family Fitness Run.

**Section 3. Detours.** The President and Board of Trustees further agree that if used, all weather detour signage allowing traffic around the Marked Route shall be conspicuously marked and judiciously police patrolled by the Village Police Department for the benefit of traffic detouring from the Marked Route.

**Section 4. Insurance.** Advocate Health & Hospitals Corporation shall provide to the Village evidence of liability insurance in the amount of \$3,000,000 in the aggregate naming the Village, its officers, employees and agents, as an additional insured prior to the date of the Family Fitness Run.



**Section 6. Effective Date.** This Resolution shall be in full force and effect from and after its passage, approval and publication according to law.
