Re: Monthly Summary – **MAY**

- Under Agenda Item 2.5, Baker Tilly Virchow Krause & Company has completed the fiscal year 2013 report. A review of the draft of the Financial Statements and Report on Internal Controls took place at a meeting of the Finance Committee on April 17, 2014. Copies of the audit report are distributed by June 30, 2014 to the state Comptroller's Office and the four counties. Audit reports are also available at www.barringtonhills-il.gov/treasurer.
- The Illinois Municipal Retirement Fund (IMRF) reported 2013 investment returns at 20%. By comparison, the 2012 investment returns were 13.7%. The preliminary employer contribution rate for 2015 is 4.14% compared to 5.86% for 2014. The savings could range from \$6,000 to \$12,000 for 2015 as salary rates on current IMRF employees will need to be taken into account to provide a definitive monetary value.
- Property tax bills have been mailed. McHenry County taxes are due on June 4, 2014. Kane County is due June 2, 2014. Lake County taxes are due on June 5, 2014. Factors that impact the total tax bill include the changes in tax rates, EAV, appeals, percentages of burden by County, and state multiplier. See attached copy of tax distribution confirmation from Lake County.
- The semi-annual debt service interest payment of \$24,615.00 is due July 1, 2014. The final principal and interest payment of \$254,750 is due on January 1, 2020.
