  - 3.1. April 25<sup>th</sup> Roadside Trash Pickup- Jan reports he estimates we will have 50 volunteers and 12-16 team leaders. Safety for the volunteers is high priority. Jan and Josie will drive around to determine specific locations that need clean up. Jan and Josie will take inventory of flags and vests and other items that are needed that day.
  - 3.2. Earth Week-April Prairie MS initiative & HEC response- Jenn K- P. Denise reported in Jenn K's absence. Overall it was a big success and a good turnout. Styrofoam containers filled their containers. The textile bin was less than 1/2 full. They received 20 Cubic yards of recyclable electronics. 15 high school kids assisted.
  - 3.3. Teasel Attack- Diane Bodkin- Diane B reported that 3 areas were evaluated. (back of BVH, by the tower and along Algonquin Road). Diane reported that stalks are down and rosettes are prominent. Diane has 3 recommendations. 1) Spray Garlon now. 2) Have a small group of volunteers to spray with Round Up in a very controlled and deliberate fashion. 3) Continue mowing all village property to keep teasel florets from forming seeds. Diane will help spray on tower side lawn. Diane will speak with S. Barrington Village Manager and report to P. Denise. Need protective gear and volunteers. Gary H., Dan C., Josie C., P Denise I., Jan G., Trustee Harrington and Sgt. Kann will help.
