Village Hall grounds: Irrigation system was drained and winterized for the season.

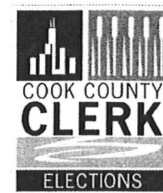
Gewalt Hamilton Associates to install snow curb markers next week.

Thank you for working with us to offer Early Voting in suburban Cook County for the November 4th Gubernatorial Election. We know the extended days and hours put a strain on your site and we truly appreciate your efforts. Early voting was a huge success. Over 139,000 voters participated in Early Voting, including those that came to the Election Day Registration sites.

The 2015 Consolidated Elections are right around the corner. The dates for Early Voting for the April 7, 2015 Consolidated Election are March 23 – April 4. In areas where primary elections will be held, the dates for Early Voting for the February 24th Consolidated Primary Election are February 9 – February 21. The Early Voting team will be in touch with you in late December if we need to use your site for Early Voting for the primary election.
