# BARRINGTON HILLS POLICE DEPARTMENT Monthly Report January 2014 Summary of Activity

#### **Attempted Burglary**

While checking an alarm, officers observed a broken basement window at a residence. Investigation showed that entry was made to the basement of the residence, but not to the main residence. Nothing appeared to be missing. The home was secured by a key holder. No evidence was obtained from the scene; case is inactive pending further developments.

#### **Damage to Property**

A vehicle was damaged while it was parked in a driveway. Investigations are waiting for video surveillance information to proceed with the investigation.

A resident reported damage to driveway lights. In checking the area, several others were also observed to be damaged. No one was seen in the area. No evidence was obtained from the scene. No further action taken.

A resident reported their mailbox damaged over night.

#### Trespass to Property

A subject was cited for trespassing on a resident's property after previously being warned to stay off the property. Case is pending a court appearance.

#### No DL / Suspended / Revoked DL

No Valid Driver's License – 3 citations; Driving while License Suspended / Revoked – 5 arrests;

#### Harassment by Telephone

A resident reported receiving harassing calls from a former tenant regarding the amount of the security deposit received back. A citation for harassment was issued. Case is pending a court appearance.

#### **Disorderly Conduct**

Three subjects were cited for disorderly conduct for using a red and blue cell phone app to stop a snow plow, allowing them to pass. The case is pending a court appearance.

#### **Domestics**

Officers responded to two domestics. Both were verbal in nature. The parties agreed to stay separated for the night. All parties were given domestic violence handbooks. No further action taken.

#### **Premise Check**

Officers discovered an unsecured door during a residential house watch. The premise was checked for signs of burglary and secured. Key-holder was notified.

#### Civil Matter

A resident reported they had hired a contractor to remodel their basement. The complainant stated that the contractor has failed to proceed with the work that he has received payment for. The contractor stated that 85% of the work had been completed and he was told not to return by the resident, as she was not pleased by the project time frame. Case is pending civil action by the complainant.

#### **Vehicle Lock Out**

Officer assisted one subject gain entry into their vehicles.

#### <u>Alarms</u>

Officers responded to six burglar alarms with unsecured doors. The premises were checked for signs of burglary and key-holders were notified.

#### Citizen Assist

A resident contacted BHPD to report that her child left the house after an argument. Her concern was with the extreme temperatures, he wasn't properly dressed. The subject was located and transported to a safe location. No further action taken.

#### Suspicious Circumstances

Officers responded to a residence with the entry door standing wide open. On arrival, the home was checked and secured. No problem found.

#### **Snowmobile Complaint**

An officer responded to a report of a snowmobiler riding on private property. The officer followed the tracks and spoke with the rider. The rider was advised to stay off private property. No complaints were signed.

#### **Animal Incidents**

A stray dog was taken to Golf Rose Kennel and later returned to its owner.

Three injured deer were terminated.
