Credit Card Fraud

A resident reported that he was contacted by an online company to confirm a delivery address on an order. In speaking with the company, he discovered that his information had been used to fraudulently open an account and place an order. The online company closed the account and will have their fraud department investigate. The victim is not being held liable for the charges. The credit card company is investigating. No further action taken.

Harassment by Telephone

A resident reported receiving harassing calls from a former tenant regarding the amount of the security deposit received back. A citation for harassment was issued. Case is pending a court appearance.

Domestics

Officers responded to one reported domestic. The parties agreed to stay separated for the night. Both parties were given domestic violence handbooks. No further action taken.

Assist Other Agency

Officers assisted a South Barrington PD officer in lock-up and in searching a prisoner.

An assist to other agency report for found property was taken by BHPD when a purse found outside our jurisdiction was dropped off at BHPD. Hoffman Estates PD was contacted and the property owner was notified.

Vehicle Lock Out

Officers assisted two subjects gain entry into their vehicles.

Alarms

Officers responded to one burglar alarm with an unsecured door. The premise was checked for signs of burglary and key-holder was notified.

Open Door

While on patrol, an officer observed a home for sale and the front door standing open. In checking the residence, it was determined to be a vacant home. The real estate company was notified and the residence was added to the house watch list.

Lost Property

A resident contacted BHPD to report a lost driver's license.

Damage to Property

Two residents reported damage to their mailboxes over night. No one was seen in the area. No further action taken.

Suspicious Circumstances

A resident reported a suspicious phone call with the subject stating he was from the Cook County Sheriff's office and that the complainant owed back taxes. The caller stated that if the complainant didn't pay within the next 10 minutes, that he would be arrested. The officer advised that it sounded like a scam. The officer attempted to contact the caller, without success.

Snowmobile Complaint

An officer responded to a report of a snowmobiler riding on private property. The officer followed the tracks and spoke with the rider. The rider was advised to stay off private property. No complaints were signed.
