# BARRINGTON HILLS POLICE DEPARTMENT Monthly Report July 2014 Summary of Activity

#### <u>Theft</u>

The Country Club reported items missing out of golf bags. Case remains open, pending further leads.

While checking an abandoned building, an officer observed that the air condition units had been removed. The property owner is attempting to locate the serial numbers. Case remains under investigation.

A resident reported a missing bicycle. No one was seen in the area.

Three residents reported missing "No Bike Lanes" signs that we posted in their yard.

A business reported the theft of several wooden pallets overnight. Video surveillance was reviewed and the offender was identified. In speaking with the offender, it was determined he had been given permission to take them. Case closed.

#### Damage to Property

While checking an alarm at a residence, a shattered sliding door was discovered. It appeared that the glass was shattered by a landscaping rock, which was located inside the doorway. Entry was not able to be gained to the home, only the sunroom. Everything else appeared to be untouched. The resident was contacted and arrangements for a board up company were made. No further action at this time.

A resident reported that the glass in some of the barn windows was broken. No one was seen in the area. The resident declined to be added to the house watch list at this time. No further action.

#### DUI's / No DL / Suspended / Revoked DL

DUI's - 1 arrest; No Valid Driver's License - 7 citations; Driving while License Suspended / Revoked - 2 arrests

#### <u>Harassment</u>

A resident reported receiving harassing phone calls. The complainant stated the caller had done some work at the residence. In contacting the offender, the officer was advised that the check the complainant gave him for the completed work, had bounced. The officer advised him that calling and harassing the complainant was not the way to handle the situation. The caller advised he would come into BHPD and make a report for theft of services. No further action taken.

A resident reported receiving harassing phone calls. The officer was unable to make contact with the caller. The complainant was advised to block the number.

#### **Domestics**

Officers responded to two reported domestics. Both were verbal in nature. All parties were given domestic violence handbooks. No further action at this time.

#### **Civil Matter**

A complainant came into BHPD regarding a check he received for doing repairs on a vehicle, and the check writer had stopped payment on the check. In speaking with the subject that stopped payment on the check, he advised that the work was not done properly and would have to be fixed by someone else. Both parties were advised that this was a civil matter. No further action taken.

#### Lockout

Officers responded to two vehicle lockouts. Entry was gained.

#### <u>Alarms</u>

Officers responded to four burglar alarms with unsecured doors. The premises were checked for signs of burglary and key-holders were notified.

#### Suspicious Circumstance

A resident reported receiving a suspicious phone call from someone claiming to be from Publishers Clearing House. The caller advised the complainant that she had won a prize and they would be over to present it to her; however the caller said she needed to first go pick up a "Green Dot Money Pack Paper Scratch Card" from the dollar store. The complainant was concerned that the caller was just trying to lure her out of her home. The officer stayed in the area for a while to see if anyone would show up and the home was placed on an extra watch.

#### **Unwanted Subject**

A resident reported that he didn't want his daughter's boyfriend at his residence. He requested BHPD contact him and advise him he was not welcome on the property. Contact was made and warning given. No further action taken.

#### Juvenile Intervention

A nanny for a residence reported that was of the teenage children jumped out of the vehicle and was walking, refusing to get back in. On arrival, the officers met with the juvenile. The father responded to the scene and the teenager was released to his custody.

#### **Animal Incidents**

A garbage company employee was bitten while attempting to pick up the garbage at a residence. The animal's owner was notified of the 10-day observation requirement. Information was turned over to animal control for follow-up. Medical attention was declined.

One dog was picked up by BHPD and was returned to its owner

#### **Attempted Suicide**

Officers responded to a 911 call of a subject unconscious and not breathing. On arrival, paramedics advised there was a pulse. It appeared the victim had taken an overdose of drugs. The subject was transported to the hospital for treatment. No further action taken.

#### **Target Permits**

One target shooting permit was issued during the month of July.

#### Deposits / Refuse.

While on patrol, an officer observed a vehicle on a dead end with a large amount of freshly deposited landscape waste. The subject removed the debris and was also cited for dumping. Case is pending a court appearance.
