**August 2014 Summary of Activity**

**Domestic Battery**

Officers responded to a report of a domestic battery. One subject was taken into custody and held for bond court.

**Theft**

A resident reported that his vacant home had items removed. It is unknown when the theft occurred. There were no signs of forced entry to the home.

Two residents reported the theft of "No Bicycle Lanes in Barrington Hills" signs.

A fire pit was reported stolen from a local church. No one was seen in the area.

**Damage to Property**

Light fixtures were reported damaged at a local church.

While conducting a premise check of a vacant building, a window was discovered to be broken. It does not appear that entry was made. A key holder was notified.

**Criminal Trespass to Property**

A resident reported that the neighbor had set up an ATV trail, which was on his property. The officer made contact with the neighbor and advised them that they were trespassing and all activity on the neighbor's property was to stop immediately. The neighbor advised that he understood. No further action taken at this time.

**No DL / Suspended / Revoked DL / Possession of Cannabis**

No Valid Driver's License – 4 citations; Suspended Registration – 1 arrest; Possession of Cannabis – 2 citations.

**Harassment**

A resident reported receiving harassing phone calls. The complainant stated the caller was a neighbor of his home under construction. He stated that the caller was complaining about a drainage issue and the heavy rain. The caller was advised that the Village Engineer and the builder were aware of the situation and calls should be directed to the Village Engineer.

A business owner reported receiving numerous hang up calls. The officer left a message at the number the incoming calls were coming from. The calls stopped. No further action taken.

### **Lockout**

Officers responded to seven vehicle lockouts. Entry was gained.

### **Alarms**

Officers responded to six burglar alarms with unsecured doors. The premises were checked for signs of burglary and key-holders were notified.

### **Lost Property**

A resident reported he lost his wallet. He had already canceled his credit cards, but wanted to report his driver's license lost. A report documenting the incident was generated. No further action taken.

### **Driving Complaint**

A bicyclist reported that a vehicle stopped abruptly in front of her, causing her to go off the road. The officer spoke with the vehicle owner; he advised he had stopped abruptly to take a photo of a bird. He was unaware that he caused the bicyclist to go off the road.

### **Identity Theft**

A resident reported that she received an invoice for wireless service on an iPad. The complainant advised that she didn't have an iPad or order this service. The complainant contacted the service provider and canceled the service.

### **Juvenile Intervention**

A resident requested assistance in getting their daughter removed from Facebook. The officer assisted by contacting Facebook and going through the process of getting her removed.

### **Animal Incidents**

One dog was picked up by BHPD and was returned to its owner; three dogs were taken to Golf Rose Kennel and later released to their owner; two dogs were released to Strays Halfway House for adoption.
