Earlier this spring it was noted that the pavement surface on Healy Road had deteriorated significantly over the past winter and would require substantial patching. We had requested a quote be provided by the Cuba Township Highway Department to patch the road, but the price quoted was well beyond the threshold at which competitive bidding is required.

Consideration was given to including this patching quantity in the 2014 Road Program. However, the bid package for this work is still in progress. Due to the IDOT contract review process for MFT projects, if a contract is awarded at the July 28<sup>th</sup>, 2014 Board meeting the 2014 Road Program construction would likely begin in late August or early September.

After relaying this information to the Roads & Bridges Committee, it was determined that a separate bid package would be prepared for patching on Healy Road. The project is currently out to bid, with a bid opening scheduled for Wednesday, July 2, 2014. If the Board elects to schedule a special meeting the week of July 7, 2014, construction could begin as early as late July, five to six weeks earlier than if the work is included in the 2014 Road Program. A copy of the bid advertisement is attached.

2. **AVAILABILITY OF CONTRACT DOCUMENTS:** Plans, Specifications, Bid Forms and other Contract Documents may be obtained from **Gewalt Hamilton Associates, Inc., 820 Lakeside Drive, Suite 5, Gurnee, Illinois, 60031 (847-855-1100)**, beginning Wednesday, June 18, 2014. This project will be bid as a Unit Price Contract. A non-refundable deposit of \$20.00 is required for each set.
3. **WAGES OF EMPLOYEES:** **Not less than the prevailing rate of wages as found by the Department of Labor or** determined by a court on review shall be paid to all laborers, workers and mechanics performing work under this contract. Certified payroll requirements will apply.
4. **LOCATION/DESCRIPTION OF WORK:** Approximately 1000 square yards of Class D Patching, 6" on Healy Road, between Penny Road and IL Rte. 68.
5. **CONSTRUCTION SCHEDULE:** Construction is to begin as soon as possible after execution of the contract and is to be completed by August 8, 2014.
