The Kane County Division of Transportation has completed preliminary plans (60% completion) for the Longmeadow Parkway project and has provided these plans to the Village for initial review. Though still preliminary in nature, the plans provide greater detail than previously provided concept plans regarding the planned roadway improvements and how they would impact Autumn Trail, IL Rte. 62, and adjacent properties.

The Village of Barrington Hills would like to invite you to a neighborhood meeting on Wednesday, October 8th, 2014 at 7 pm at the Village Hall. The intent of this meeting is to discuss the details presented in the preliminary plan set and to help determine the scope of the Village's response to Kane County DOT. While the Village does not have any direct involvement in the design or planning of this project, nevertheless we would like to make sure that feedback and concerns from residents are heard by the appropriate parties at the Kane County Division of Transportation.
