Re: Monthly Summary – **MAY BOT MEETING**

- Under Agenda Item 2.5, Sikich, LLP has completed the fiscal year 2014 audit. A review of the draft of the Financial Statements and Report on Internal Controls took place at a meeting of the Finance Committee on April 20, 2015. Copies of the audit report are distributed by June 29, 2015 to the state Comptroller's Office and Cook, Kane, Lake and McHenry Counties. Audit reports are also available at www.barringtonhills-il.gov/treasurer.
- Motor Fuel Tax (MFT) allotment for March, 2015 was reduced as shown on Treasurer's Report 2.1 but has returned to normal levels as of the April, 2015 allotment distribution. See attached notification from Illinois Department of Transportation regarding the MFT Fund Sweep.
- The Illinois Municipal Retirement Fund (IMRF) preliminary employer contribution rate for 2016 is 3.41% compared to 4.14% for 2015. The savings could range from \$21,000 to \$26,000 for 2016 as the outsourcing of dispatch and salary rates on retained and current IMRF employees will need to be taken into account to provide a definitive monetary value.
- Property tax bills have been mailed. McHenry County taxes are due on June 4, 2015. Kane County is due June 1, 2015. Lake County taxes are due on June 3, 2015. Factors that impact the total tax bill include the changes in tax rates, EAV, appeals, percentages of burden by County, and state multiplier.
- The semi-annual debt service interest payment of \$21,150.00 is due July 1, 2015 and will be included in the bills for approval at the June 22, 2015 BOT Meeting. The final principal and interest payment of \$254,750 is due on January 1, 2020.
