## **Proclamation**

### **RESOLUTION OF PROCLAMATION APPRECIATING DOCTOR PAMELA COOLS FOR 15 YEARS OF DEDICATED SERVICE**

**WHEREAS**, the Village of Barrington Hills (the “Village”) is a home-rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and,

**WHEREAS**, the Village’s Boards, Commissions and Committees are entirely comprised of residents; and,

**WHEREAS**, the members of Boards, Commissions and Committees serve as volunteers without compensation; and,

**WHEREAS**, Dr. Pamela Cools served before and during her official service to the Village, volunteered her time to help make the Village’s Fall Festival a huge success; and,

**WHEREAS**, Cools served on the Village’s Communications Committee from 2007 - 2011; and,

**WHEREAS**, Cools served on the Village’s Plan Commission from 2013 - 2022; and,

**WHEREAS**, in 2017 Cools was appointed to Chairman of the Plan Commission, she served in this capacity until June 2022; and,

**WHEREAS**, Cools led the Plan Commission’s effort to review and revise the Village of Barrington Hill’s Comprehensive Plan, beginning in 2018; and,

**WHEREAS**, throughout the review process Cools spent countless hours working with fellow members and staff to revise the Plan, creating not only a sound guidebook for Village Officials, but a beautiful document that any resident could understand and enjoy; and,

**WHEREAS**, in 2019 the revised Comprehensive Plan was recommended by the Plan Commission and ultimately approved by the Village’s Board of Trustees; and,

**WHEREAS**, Cool’s service as a volunteer Committee/Commission member for the Village of Barrington Hills lasted for nearly 15 years.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Barrington Hills, Counties of Cook, Kane, Lake and McHenry, and the State of Illinois as follows:

**SECTION ONE:** That Dr. Pamela Cools is hereby officially recognized and commended for the exemplary service she has provided to the Village serving as a Committee Member, Commission Chairwoman for a combined nearly 15 years.

**SECTION TWO:** That a copy of this Resolution shall be made a part of the Official records of the Village of Barrington Hills so that future generations will know of the contributions Dr. Pamela Cools has made to the Village.

**SECTION THREE:** That we join with the residents of the Village in extending personal best wishes to Dr. Pamela Cools on her future endeavors.
