

**A RESOLUTION AUTHORIZING THE PURCHASE OF A POLICE VEHICLE BY
THE VILLAGE OF BARRINGTON HILLS**

WHEREAS, the Village of Barrington Hills (the "Village") is a home-rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and

WHEREAS, the Village Police Department is in need of one (1) new Ford Interceptor Police Utility Vehicle to adequately perform the duties and obligations of the Village Police Department and to serve and protect the citizens of the Village; and

WHEREAS, it is the recommendation of the Village Police Department that the Village President and Board of Trustees authorize the purchase of one (1) new Ford Interceptor Police Utility Vehicle at an expense not to exceed \$40,000.00; and

WHEREAS, based on the recommendation of the Village Police Department, the President and Board of Trustees has determined the purchase of one (1) new Ford Interceptor Police Utility Vehicle at an expense not to exceed \$40,000.00, is in the best interests of the citizens of the Village.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, located in the Counties of Cook, Kane, Lake and McHenry, Illinois, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: The Chief of Police is authorized to purchase one (1) new Ford Interceptor Police Utility Vehicle at an expense not to exceed \$40,000.00, to be taken from the Village General Fund.

SECTION THREE: This Resolution shall take effect immediately upon its passage and approval as provided by law.

Subject: Police Vehicle Replacement

Recommendation:

Purchase one (1) 2023 Ford Police Interceptor Utility vehicles from Currie Motors of Frankfort, IL, under the Suburban Purchasing Cooperative Contract. The cost for this vehicle will not exceed \$40,000.00 (not including equipment and upfitting).

Analysis:

This purchase is required in order to replace one aging 2018 police vehicle with 148k miles. Vehicles are normally prepared for surplus auction at around 120k-130k miles.

Upon approval, I will order the new vehicles and make the necessary arrangements to prepare it for service.
