WHEREAS, during Croll's time as Trustee for the Village, he served as Chairman of 26 Finance Committee Meetings and attended 100 Board of Trustees meetings.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, Counties of Cook, Kane, Lake and McHenry, and the State of Illinois as follows:

SECTION ONE: That Bryan C. Croll is hereby officially recognized and commended for the exemplary service he has provided to the Village serving as Trustee for the last 8 years.

SECTION TWO: That a copy of this Resolution shall be made a part of the official records of the Village of Barrington Hills so that future generations will know of the contributions Bryan C. Croll has made to the Village.
