

**RESOLUTION OF PROCLAMATION APPRECIATING TRUSTEE
COLLEEN KONICEK HANNIGAN
FOR 10 YEARS OF DEDICATED SERVICE TO THE VILLAGE**

WHEREAS, the Village of Barrington Hills (the "Village") is a home-rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and,

WHEREAS, the Village's Board of Trustees is entirely comprised of residents that serve as volunteers without compensation; and,

WHEREAS, on April 9, 2013, Colleen Konicek Hannigan was elected, by her fellow residents to a four-year term as Trustee for the Village; and,

WHEREAS, in 2013, Konicek Hannigan cofounded "The Hills Are Alive" fall festival, an annual festival, which continues to this day, bringing together residents of all ages for a fun and nature filled afternoon; and,

WHEREAS, on May 11, 2015, the Board of Trustees approved the appointment of Konicek Hannigan to the position of President Pro Tem; and,

WHEREAS, on April 4, 2017, Colleen Konicek Hannigan was reelected, to a second four-year term as Trustee for the Village; and,

WHEREAS, Konicek Hannigan served as designated alternate to the Barrington Area Council of Government's Executive Board from 2018 - 2021; and,

WHEREAS, on May 3, 2021, Colleen Konicek Hannigan was appointed to fill the vacancy left on the Board of Trustees, for an additional two-year term as Trustee for the Village; and,

WHEREAS, during Colleen Konicek Hannigan's time as Trustee for the Village she attended 137 Board of Trustees meetings and countless other Board, Committee & Commission meetings.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, Counties of Cook, Kane, Lake and McHenry, and the State of Illinois as follows:

SECTION ONE: That Colleen Konicek Hannigan is hereby officially recognized and commended for the exemplary service she has provided to the Village serving as Trustee for the last 10 years.


