SECTION TWO: The Chief of Police is authorized to purchase a security video recording and management system from Current Technologies Corporation for a total amount not to exceed \$37,000.00, quote attached as Exhibit A, and is authorized to execute agreements related thereto, subject to Village Attorney review and approval.

SECTION THREE: This Resolution shall take effect immediately upon its passage and approval as provided by law.
