

RESOLUTION AUTHORIZING THE REPLACEMENT OF AN OVERHEAD DOOR FOR VILLAGE PROPERTY LOCATED AT 120 W. ALGONQUIN ROAD

WHEREAS, the Village of Barrington Hills (the “Village”) is a home rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and

WHEREAS, accordingly, the Village is authorized to make improvements to Village property and to select contractors and professionals to assist with and perform Village property improvements; and

WHEREAS, the Village has entered into an Intergovernmental lease (the “Lease”) with the Barrington Countryside Fire Protection District (“Fire District”) authorizing the Fire District’s use of the Village’s property and building located at 120 W. Algonquin Road, Barrington Hills, IL, for a Fire Station, which Lease is in effect; and

WHEREAS, under the Lease, the Fire District is responsible to maintain and repair interior elements of the building and Village is responsible for repair of exterior elements of the building, including exterior overhead doors used for entry and exit of emergency vehicles; and

WHEREAS, upon notice provided by the Fire District, the Village has confirmed that the overhead door of the Fire Station building, used for entry and exit of emergency vehicles, is in need of repair for an amount not to exceed \$13,000.00; and

WHEREAS, accordingly, the President and Board of Trustees of the Village hereby determine that it is in the best interests of the health and safety of the residents of the Village to authorize the repair of the overhead door of the Fire Station building, used for entry and exit of emergency vehicles for an amount not to exceed \$13,000.00.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, located in the Counties of Cook, Kane, Lake and McHenry, Illinois, pursuant to home rule authority, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: The President and Board of Trustees of the Village hereby authorize the repair of the overhead door of the Fire Station building, used for entry and exit of emergency vehicles, for an amount not to exceed \$13,000.

SECTION THREE: The Village President, Director of Administration and Village Attorney are hereby directed to take any and all action necessary to effectuate the repair of the overhead door of the Fire Station building, used for entry and exit of emergency vehicles, for an amount not to exceed \$13,000.

SECTION FOUR: This Resolution shall take effect immediately upon its passage and approval as provided by law.
