

**RESOLUTION OF PROCLAMATION RECOGNIZING  
WILLIAM N. WALSH ON 33 YEARS OF DEDICATED SERVICE**

**WHEREAS**, the Village of Barrington Hills (the "Village") is a home-rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and

**WHEREAS**, William N. Walsh was hired as a Communications Officer for the Village of Barrington Hills on September 16 , 1993, and transitioned to Community Service Officer in December of 2006; and,

**WHEREAS**, in addition to his Patrol responsibilities, also served as Evidence and Property Custodian, Evidence Technician, Fleet Manager, Accreditation Manager; and,

**WHEREAS**, William N. Walsh served in many additional training roles to assist in the development and growth of both civilian and sworn staff members; and

**WHEREAS** In his role as Accreditation Manager, led the Department to receive national Accreditation Awards through the Commission on Accreditation for Law Enforcement Agencies 7 times in the years 2004, 2007, 2010, 2013, 2016, 2019, and 2023; and

**WHEREAS**, was assigned in 2017 to the Major Case Assistance Team (M.C.A.T.) as an Forensic Technician, promoted to a supervisory role in 2021 and assisted M.C.A.T. and it's 24 member agencies by investigating nearly 100 homicides during that time frame; and,

**WHEREAS**, the Village is proud of William N. Walsh's many earned accolades and awards during his career which include a Meritorious Conduct Award, Baby Delivery Award, several Department Commendations, and numerous citizen letters of appreciation.

**NOW, THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Barrington Hills, Counties of Cook, Kane, Lake and McHenry, in the State of Illinois, as follows:

**SECTION ONE:** That William N. Walsh is hereby officially recognized and commended for the exemplary service, leadership and dedication he has provided to the Village for the last 33 years.

**SECTION TWO:** That a copy of this Resolution shall be made a part of the official records of the Village of Barrington Hills so that future generations will know the contributions William N. Walsh made to the Village.
